(Hereinafter the parties herinabove be called and referred to individually as the Trustees and jointly called as Board of Trustees, which expression unless the context be required to the contrary shall mean and include their survivor, survivors, heirs, executors, administrators or the said survivors or his assigns and the Trust or Trustees for the time being for these presents at any time from the date of creation of the Trust.)

WHEREAS the parties herinabove were desirous of creating a Public Charitable Trust for construction and maintenance of NITTA ANANTHANA SAI CHAM for the purpose of visiting pilgrims and ved dharma of SRI YOGANANDA LAKSHMI NARASIMHA SWAMY, a great and famous VAISHNAVAIT temple on the banks of river KRISHNA.

WHEREAS the trustees have agreed to become the FIRST AND FOUNDER TRUSTEES of those presents by their being party to executing these presents.

AND WHEREAS in pursuance of the above, the settlers have created and constituted on 02-05-2006 and in accordance Public Charitable Trust and each made a donation of Rs 1,116/- to the Trust and contributed cash to the Trustees herein for holding the same in Trust

AND WHEREAS it is the desire of the settlers that the Corpus of the Trust should be further augmented from time to time by way of gifts and donations.

WHEREAS it is the desire of the Settlers to provide in writing the terms and conditions governing the Trust and therefore this Deed of Trust in writing to avoid any possible misapprehensions in the administration of the Trust.

NOW THEREFORE THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

1. That with a view of effectuating the said desires, the Settlers do hereby declare that they have constituted a Trust on 02-05-2006 and have transferred and delivered the sum of Rs 5,580/- (Rupees five thousand and five hundred eighty only) the Trustees to hold the same in Trust as corpus fund to be used exclusively for the objects more specifically mentioned herein and subject to the powers, conditions and provisions of the Trust Deed hereinafter appearing.
2. The Trustees do hereby declare that they shall hold and stand possessed of the said sum, together with such additions and accretions thereto as may be made by donations, profits, gains, and incomes and otherwise upon the said Trust subject to the said powers, conditions and provisions.
3. The Trust hereby established and constituted shall be called and known as SRI YOGANANDA LAKSHMI NARASIMA SWAMY SEVA TRUST, JAGGAYY. PET

4. The office of the Trust shall be situated at D.no 2/80 Vedadri, Jaggayyapet Mandalam or at such other places as the Trustees may from time to time think fit.
5. The trustees shall hold the Trust properly for being applied in one or more of the following charitable objects within India, for the benefit of the members of General Public without any distinction of caste, colour, sect, creed or sex.
 - To construct a building to maintain the NITYA ANNADANAM at Vedadri near to the temple of SRI YOGANANDA LAKSHMI NARASIMHA SWAMY in the land that may be acquired either by assignment or permanent lease.
 - Offering free meals to the visiting pilgrims.
 - To provide medical aid and relief to the visiting pilgrims.
 - For running and maintaining goshala for protecting and maintaining the cows.
 - For the advancement of any other object or general public utility not involving the carrying on of any activity for profit.
6. GHANKOTA VENKATA GOPALA KRISHNA MURTHY shall be the Chairman of the Trust, JANAMANCHI JANARDHANA RAO Vice Chairman, TADIMETI LAKSHMI KUMARI shall be the Managing Trustee and KUCHIBHOTLA NAGA MOHANA KUMAR the Treasurer of the Trust.
7. All the above said TEN Trustees shall be the Trustees for their lifetime. The Trustees in their meeting shall appoint the other office bearers.
8. It shall be lawful for the Trustees from time to time to frame such rules and regulations for the management and administration of the Trust and Charities as they shall think fit and such rules and regulations shall not be inconsistent with the terms and intents of those presents.
9. To facilitate day-to-day supervision and administration of the Trust property, it shall be lawful for the Board of Trustees herein to constitute and appoint an Executive committee from time to time not exceeding for period of two years.
10. Any question arising in the administration of the Trust shall be decided by the majority of the Trustees acting for the time being. In case of difference of opinion arising among the Trustees, the matter shall be decided according to the casting vote of the Chairman of the trust who has also a right for casting vote.
11. The Trustees shall keep or cause to be kept a minute book of their proceeding and a Chartered Accountant shall audit proper book of account and the accounts of the Trust.
12. The Trustees shall be entitled from time to time to open and maintain a Bank Account or Accounts in the name of the Trust at such Bank or Banks as they may from time to

time decide and the same may be operated by any two of The Chairman, the Managing Trustee and the Treasurer.

13. It is open to the Trustees to accept voluntary contributions, subscriptions, gifts, donations in cash or movable or immovable properties nor any specific purpose or for building up Corpus or for construction of any building or for the fulfillment of any of the objectives of the Trust or for meeting the day-to-day expenses or otherwise.
14. The Trustees shall be in their absolute discretion to invest the trust monies in any of the securities approved by them, and may acquire or obtain on lease or otherwise any immovable property including leaseholds any part of India.
15. It shall be lawful for the majority of Trustees to appoint OR remove any person or persons to be Trustee or Trustees of this Trust on a permanent basis or for such period as may be specified.
16. The Trust is irrevocable and will continue in perpetuity
17. The income earned out of carrying of the objects of the Trust or of such accumulations of income and/or any such other income funds of the Trust shall be solely utilized for furtherance of the objects of the Trust and no part of it shall be distributed among the members of the Trust by way of Profit or dividend or otherwise. Or divest any of the funds or income of the trust detriment to the objects of the Trust
18. The Trust shall not carry out any of its activities anywhere outside India
19. It shall be lawful for the Trustees to accumulate the surplus and invest the same wherever required in accordance with the provisions of the Income Tax Act, 1961 as may be in force from time to time
20. It declared that in the event of dissolution of the Trust the assets remaining shall be transferred to any other institution with similar objects and aims which has been recognized by the Income Tax Authorities and registered under Sec.12A of the Income Tax Act, 1961
21. No alterations and amendments, deletions and additions to the rules of the Trust Deed shall be made without the prior approval of the Commissioner of Income Tax, Vijayawada.

21. It is further declared that the income of the Trust or the Profits or any part thereof shall not applied for the benefit of the Settlers of the Trustees of the Trust or their relatives or persons more particularly mentioned under Sec .13 of Income Tax Act, 1961.

TECHNICAL DATA

Formation of Roads, Drains, Culverts

It is proposed cement concrete road with murrum cushioning of 0.45m, and compacting with a roller after watering the surface, then a bed concrete 0.10m thick is laid finally covered by cement concrete 1:2:4 proportion and a thickness of 0.15m.

Where as Cement Concrete side drain are assumed on either side of the road along the pathways, these drains are connected to main drain to dispose, off the water.

Necessary culverts are provided where side drains are crossing the main & sub main roads. The culverts are built up in stone masonry with cc bed and covered with deek RCC Slab of designed thickness.

Tapping of IIT & IT Power lines

This needs power lines & installation of Transformers & fixing up the Street lights, High mast light poles etc.

Water supply Arrangements


Over head water tanks are proposed. Main water pipe is to be laid from proposed Barrage & connected to the water treatment plant with necessary distribution network. Construction of Compound Wall It is proposed to construct the compound wall to safe guard the Temple Premises.

Archways & Gates

Consturctions of entrance Archeays & Ways are to be kept in provision, the entrance arch gives a grand look to entrance of the Temple. Along with security rooms & check posts.

Interlock for Pavements & Paved Parking

Interlock Pavement to the foot path is necessary to maintain road clean from dust & makes pedestrains to walk over it, same as a proposal for parking area is to be developed with heavy duty pavers.

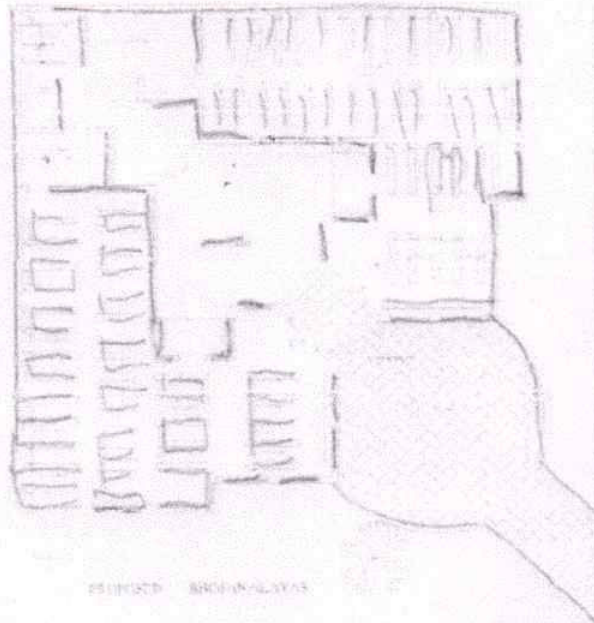
Contour Maps 1,2&3
